Stonebridge Pool Rules and Regulations

Membership:

- *** SPOA Pool Membership is extended only to homeowners and their families living in the Stonebridge POA who are in good standing in the community which includes being current on their Homeowner's Association assessments and not in violation on any covenants. Any family member not living in a SPOA property will be considered a guest.
- *** Members NOT in good standing may NOT come as another Homeowner's guest. This includes minor children whose parents are NOT in good standing.
- *** Renters of a SPOA property are permitted to become members provided that the homeowner is in good standing in the community and SPOA assessments have been paid. If payments of Homeowner's Association assessments are determined to be delinquent, pool privileges will be revoked until the account is no longer delinquent. Renters are required to show a <u>Rental Agreement</u> when obtaining membership to the Pool.

Admission:

- *** Admission to the pool requires a valid Membership Registration Form to be filled out and signed by the homeowner prior to pool opening and passes have been issued. No admission to the pool without a pool pass. This includes children being brought to the pool by someone other than their parents.
- *** In order to watch another member's minor child/children for more than a 10-minute period, you must be listed by the parent on their membership form.
- *** Members are required to check in with the attendant or certified pool operator on duty that will sign in members and punch their guest pass upon entering the pool and sign out members and their guest upon leaving the pool area.
- *** We will prosecute anyone trespassing in or on the pool grounds after posted pool hours.

Consequences for adults breaking the rules and regulations are as follows:

- *** Adults not following the rules and regulations are given one warning prior to be required to leave the pool area for the remainder of the day.
- *** Habitual noncompliance of the rules will be grounds to have membership suspended or revoked.
- *** A single adult can accompany a maximum of four minor children at any one time. An exception will be made for families with more than four minor children.

Minor Residents (14 or Under):

- *** Members age 14 or under must be accompanied at all times while at the pool by a parent, legal guardian or responsible SPOA resident (Who is listed on the Membership Registration Form) and is 18 or older.
- *** FAILURE TO DIRECTLY SUPERVISE MINOR CHILDREN AT ALL TIMES WILL BE GROUNDS FOR LOSS OF POOL PRIVILEGES.

 PARENTS (NOT THE ATTENDANTS) ARE RESPONSIBLE FOR SUPERVISION OF MINOR CHILDREN. DIRECT SUPERVISION

 MEANS "LINE OF SITE."
- *** Any child not potty-trained must wear rubber pants or swim diapers while in the pool.
- *** All other Children must remain behind the white line on the pool deck during adult swim.

Consequences for children (14 or under) breaking the rules and regulations:

- *** 1st offense A verbal warning will be given
- *** 2nd offense Member must sit outside of the pool water for 15 minutes
- *** 3rd offense Loss of pool privileges for the rest of the day

General Regulations:

- Attendants and Certified Pool Operators will be on duty at all times.
- Walk in the pool area, no running, skipping, pushing, rough play or towel slapping will be allowed.
- No diving is allowed. No cartwheels, flips (front or back) off the side of the pool are allowed.
- No jumping into the pool in the RED painted area. No jumping over people or into rings in the pool.
- No profanity or improper behavior is allowed.
- No alcoholic beverages or illegal drugs are allowed in the pool area.
- Anyone suspected of being under the influence of drugs or alcohol will be asked to leave.
- No smoking or vaping in the pool area.
- Infected or sick persons will not be allowed to use the pool.
- No spitting, spouting of water or blowing the nose in the water
- Persons with cuts or open wounds will not be permitted use of the pool.
- No pets in the enclosed pool area except Registered Support Animals.
- No wheeled vehicles in the pool area except for wheelchairs and strollers
- No glassware, glass bottles or gum is permitted inside the pool area.
- Food and beverages in plastic containers are permitted. The pool area and tables must be cleared of all food and trash before leaving the pool area. Failure to comply will result in the loss of pool privileges for one week.
- Swimsuit must be worn; no cutoffs or street clothes are permitted in the pool.
- No rafts or air mattresses are permitted. Only Nerf-type balls are permitted at the discretion of the attendants.
- Water guns of any type are prohibited.
- Infant flotation rings or life vests are allowed.
- No throwing of pool toys in a manner that could harm other person.
- No slapping the noodles on the water or sides of pool.
- No sitting, hanging, or playing on the ropes or ladders.
- Please be courteous to other members and guests.
- Handicapped parking will be enforced.
- A First Aid Kit will be available on request from an adult.

Guest Regulations:

A SPOA MEMBER MUST ACCOMPANY THEIR GUESTS AT ALL TIMES

- *** Every member once they register will receive 10 guest passes. If you register before May 12th, you will receive a bonus of 5 extra passes. Each pass is good for up to 4 guests on each visit.
- *** Each member must sign in their guests and have their guest pass punched for the day. Each member is responsible for the conduct of their guest.
- *** Misconduct by guest or members may be grounds of loss of pool privileges.
